**TABLE DISPLAY FEES:** \$200.00 for (1) one table OR \$175.00/table for (2) two or more tables. Table fees cover the cost of display for the entire weekend. All tables (wall or aisle) are sold on a first come, first served basis.

### **SHOW INFORMATION & RULES:**

- Exhibitor unloading and move-in times are as follows: 2:00pm - 6:00pm on Friday February 21<sup>st</sup>, 2025 AND/OR 8:00am - 9:00am on Saturday February 22<sup>nd</sup>, 2025.
- Unloading and move-in is through service entrance towards rear of hotel. Signs will be posted.
- Exhibitors will receive a MAXIMUM of (2) badges on Saturday morning.
- The Exhibition Room will be secured during non-show hours.
- The Promoter, Legends & Stars, LLC shall have final say on all table assignments.
- Exhibitors shall not assign or sublet all or any part of said space.
- Tables are sold on a first come, first served basis.
- Your signed contract with FULL payment is required to guarantee your display table(s).
- Chairs will be provided with your table fees. Exhibitors must bring their own tablecloths or table coverings. Neither the Promoter, Legends & Stars, LLC nor the venue provides them.
- Exhibitors should display a valid tax permit issued by NY State.
- Exhibitors must always conduct themselves in a professional manner. Failure to comply will result in immediate removal. A refund will not be granted should an exhibitor be removed.
- Aisles and exits must always remain clear. The Promoter, Legends & Stars, LLC reserves the right to direct the removal of items that block walkways and exits.
- It is the discretion of the Promoter, Legends & Stars, LLC to ask to have items deemed inappropriate for display removed.
- There is absolutely NO smoking permitted in the building.

- There will be absolutely NO refunds or credits granted to Exhibitors who cancel their contract for display table(s) after February 8<sup>th</sup>, 2025.
